National Health Insurance (NHI)

• Medical Insurance System

Japan has a medical insurance system under which everyone with an address in the country must join one of the public health insurance programs. The National Health Insurance program (kokumin kenko hoken) is one such public health insurance program, and is administered by individual municipalities. Persons enrolled in this program pay 30% of costs at medical facilities for treatment covered by this insurance. Foreign residents who are registered as residents in Naka and have a resident card/special permanent resident certificate are obliged to enroll in the National Health Insurance program (after July 9, 2012). Enrolment is on the basis of households, with one Health Insurance Certificate issued per person.

• Enrolment in and Withdrawal

Anyone who is not enrolled in a public health insurance program through the workplace must join the National Health Insurance program. You cannot join or withdraw at will. Eligibility for the National Health Insurance program begins either from the date of birth, moving into the municipality, or loss of eligibility for another health insurance program at the place of employment, irrespective of when you notify the City Hall. Likewise, the insurance premium is assessed from the month in which you become eligible. If there is a delay in completing enrolment procedures, premiums are assessed retroactively for a maximum of 3 years. In such cases a large, lump—sum insurance premium is required. Be sure to complete enrolment procedures at the Tax and National Health Insurance Division in the Naka Town office within 14 days of moving to the town or the day after leaving employment.

国民健康保険

●医療保険制度

旨本では、旨本国的に住前を持つ代は誰もが何らかの込前医療保険に加入する皆保険制度がとられています。国民健康保険は公前医療保険の一つで、市区町特単位で運営しています。国民健康保険の加入者が医療機関で保険対象の治療を受けた場合、医療費の3割を支払います。那資町では住民、整鍮していて、在留力ードまたは特別教任者、記明書の交付を受けている芳は、国民健康保険に加入する義務があります。(2012年7月9首以降)。加入は世帯ごとで、1人につき1枚の保険記が交付されます。

●加入・脱退

職場で公前医療保険に加えしていない芳は、すべて国民健康保険に加えしなければならず、首直意恵による加え・脱遠はできません。資格 取得旨は富田に関係なく田里首、転える、職場の健康保険の資格喪失旨までさかのぼります。また、保険税も資格取得旨の属する月芬から課税されます。加え手続きが遅れますと最良で3年度分さかのぼって課税されます。そのため、高額の保険税を一度に納めていただくことになります。退職した旨の翌日または転入した首から、必ず14百以内に税務保険課で加入手続きをしてください。
